##### Rules

- Caravan bookings on holiday and long weekends will be charged for a minimum of two (2) nights.

##### Accommodation

- The onsite accommodation must be pre-booked and does not include the supply of linen.
- Emergency linen supply is available on request and incurs a \$10 cleaning charge
- All accommodation fees are for a couple and their children or for a single person.

##### Payment of Fees

- Fees and charges may change without notice.
- New membership and site fees are charged on a quarterly pro-rata basis.
- All payments are to be given to the Duty Fee collectors who will provide a receipt at the time of payment.
- Fees are deemed to be paid upon clearance of full payment to Nature Developments Pty. Ltd.
- All cheques are to be made payable to Nature Developments Pty. Ltd. (not Kiata Country Club) and posted to PO Box 4176 Pitt Town NSW 2756.
